

A Coordinated Response Lucas County, Ohio

Contribute

The Mental Health and Recovery Services Board (MHRSB) authorized the use of up to \$2,000,000 in State Opioid Response. Regional Opioid Crisis Flex, State and Federal Block Grant and local levy funds to contract with OhioMHAS licensed providers located within Lucas County for the purpose of maintaining essential services including access to crisis services and access to treatment services including medication and housing stability.

The Ohio Supreme Court released up to \$4,000,000 in court technology funding. This funding will enable courts to augment or obtain needed equipment and/or services for video hearings and web conferences.

The City of Toledo (\$951,152) and Lucas County (\$58,008) have been awarded Coronavirus Emergency Supplemental Funding (CESF) through the Bureau of Justice Affairs, Office of Justice Programs, Bureau of Justice Affairs. Funding is targeted for Coronavirus prevention, preparation, and response.

Regular press conferences are held by Ohio Governor Mike DeWine and Lucas County leaders to provide up to date information related to the state and local response to the COVID-19 pandemic. Lucas County leaders receive a daily briefing on Lucas County's pandemic response prepared by the Emergency Operations Center (EOC). The MHRSB is hosting a monthly virtual call with all behavioral health providers, hospitals, care providers and other health stakeholders in the community. During this meeting stakeholders provide updates on existing policies and procedures, trends, success and challenges in direct response to COVID-19.

Testing has expanded in Lucas County as part of a collaboration between the Lucas County Health Department, Board of Lucas County Commissioners and Community and Cooperate Partners to establish COVID-19 testing sites for Lucas County Residents. On June 11, the State of Ohio expanded testing for all individuals from all testing priority groups. Collaborate

The EOC was activated to coordinate the Lucas County Response to COVID-19.

Lucas County has also created a Grant Strike Taskforce charged with monitoring the Coronavirus, Aid, Relief, and Economic Security Act (CARES Act) and coordinating with local behavioral health and criminal justice stakeholders to ensure Lucas County applies for every funding opportunity possible.

Coordinate

The Screener and Linkage (SAL) Project remains operational. This project takes place inside the Lucas County Corrections Center. This project includes the screening of every person booked into the jail utilizing the Brief Jail Mental Health Screener. The second component of this project includes coordinators housed within the jail that providing brief case management to those individuals who screen positive for mental illness. The coordinators then connect individuals to treatment within the local behavioral health community.



Develop a robust cross system information sharing infrastructure

Strategies are in place to depopulate the jail. A daily review of inmates is taking place utilizing the PSA. Restrictions on inmate movement include: social distancing

and limiting number of folks held in one area. All modules contain soap, water and paper towels and are sanitized 3 times per day. All property is bagged. After each intake, staff wash their hands, apply a new set of gloves, and clean each respective processing area before the next intake. Other precautions include: limiting the amount of arrestees and officers in Booking at any given time. The jail has identified quarantine/isolation space. In addition, enhanced medical screening is taking place. All arresting officers and arrestees have their temperatures taken. Additional questions have been added to the medical screening at intake. Based on their answers the Nurse will assess and addresses each inmate. Any inmate suspected of having Covid-19 is separated (single holding cell area). Steps to quarantine the jail population are also in place such as: N-95 masks and eye protection; briefings are now held in the release area of Booking; the control booth is off limits to everyone except the assigned officer and sergeant.

closure, the facility has followed coronavirus protocol set forth by the Centers for Disease Control and Prevention and the Williams County Health Department. Measured include the option of cloth masks for the 180 staff members and 535 inmates.

New inmates are quarantined from the rest of the population for their first two weeks in a dorm area created for isolation and completely sanitized between its uses. Temperatures are taken three times daily. Six-foot distancing is a regular practice between staff and inmates. The temperatures of inmates in the regular population are taken once a day, and floors are marked with six-foot

CCNO implemented coronavirus measures on March 22. One measure included closing the facility to the public. During the

standards. Inmate training and work programs have been suspended. Area courts have been asked to consider electronic monitoring and GPS sentencing. Due to positive tests, further restrictions were put in place: CCNO temporarily suspended the acceptance of new inmates. During that time Sheriffs and judges had the ability to incarcerate individuals believed to be a risk to the public or to themselves. The Toledo Legal Aid Society (TLAS) represents approximately 20,000 indigent clients per year in six area courts. TLAS also represents clients that are being held at the Lucas County Corrections Center; CCNO; and in the Ohio prison system. TLAS has adjusted operations based on shifting court policies aligned with current state recommendations. During this time, TLAS has tried to maintain a lot of communication with our

educate employees. Although, each court adopted different approaches to handling this situation, each court has greatly reduced the number of ongoing court events. This has largely been accomplished by continuing out of custody cases. Planning involved figuring out how to be mindful of social distancing in handling our responsibilities to our clients while also developing a strategy to avoid overly burdensome caseloads once there was a return to normal court operations. TLAS has done the following in response to the Covid-19 situation: * Reduced the number of attorneys and office staff that reported to our TMC and juvenile court offices * Allowed certain staff to work remotely; * Limited the number of attorneys for court dockets * Consolidated/modified job duties * Weekly Zoom meetings for different groupings of attorneys* Circulated reports of clients in LCCC, CCNO for TMC, SMC, OMC, MMC, and LCCCP attorneys to review to file motions to modify bonds or sentences * Encouraged reviews of scheduled court events to facilitate early discussions with the prosecutor's office as to case
